Note: In addition to above following fee shall also be applicable-

- (i) Degree Fee- Rs. 200/- LL.B. This Fee shall be charged with final year Exam. forms.
- (ii) If candidate opts for improvement paper(s)/ subject(s) as per applicable rule for securing pass percentage, he/she will be charge fee equal to due paper(s)/subject(s) fee for such improvement.

In addition to above, such candidates of LL.B. Course are also eligible to fill examination form who were declared Supplementary as a result of LL.B. Exam. 2022-23 but not filled Exam. Form of Supplementary Exam. 2022-23. However, as per scheme, chance has been counted and required to fill Exam. Form accordingly.

All candidates and Principal of the College/ College Staff should go through the below mentioned brief guidelines carefully and act accordingly:-

- College must ensure to intimate all concerned students in this regard.
- Students of above courses can fill Online Examination form at University website i.e. www.alujaipur.ac.in
 Examination Portal or directly at www.aluexam.in.
- Examination form can only be accepted through online mode along with online payment of prescribed fee. After filling online examination form, student must submit the hard copy alongwith requisite documents to his/ her concerned college immediately, as per above timeline.
- College is compulsorily required to update all such filled exam forms, who are eligible to appear in
 ensuing exam at online college panel of the University and ensure to submit hard copy along with
 the requisite documents at University office latest by 24.06.2024. After passing the last date of
 exam. form online approval and submission of hard copy of exam forms at University office, it will
 not be accepted and concerned college will be liable for any consequences.
- It is noticed that many of colleges are submitting exam forms hard copies by arranging it in alphabetic order or any other order. College is requested to kindly arrange hard copies of the examination form in the same sequence of the online list generated at College Panel i.e., in Registration no. order, while submitting it at University office.

• It is also noticed that many of the colleges are not submitting hard copies of some of the duly filled examination forms along with requisite documents. So, you are requested to kindly prepare list of exam forms of only such cases which are being submitted to University physically. After passing the last date, University shall not accept any hard copies of the examination forms filled online and it shall automatically stand cancelled and such candidate (s) may not be permitted to appear in concerned examination. Kindly ensure the timeline.

• All printed exam. forms must be signed by the concerned candidates at required places.

• All printed exam. forms must be sealed and singed at all required places by the concerned Principal of the College.

Note:- All required documents with the examination forms must be arrange in following order while submitting hard copies of the filled, duly verified and online approved examination forms to the University office:

1. Examination form, duly signed by candidate and Principal of the College.

2. Print out of online successful payment of examination fee receipt.

3. Self attested photo copy of Marksheets of LL.B. I, II, III and Supplementary Class self attested Marksheet.

4. Self attested Photo copy of caste certificate, if case so. In case of OBC, it must not be three year older.

5. Original Gap Certificate declaration by candidate on Rs.50/- non-judicial stamp paper duly notarised. If candidate takes admission in any Law Course of the University previously and takes gap in admission of higher class, maximum one (01) year gap is allowed for any of class but it must be ensured that it shall not extend the maximum span period of the course.

6. If candidate takes admission at College in Law Course and attended minimum 75% classes but not filled examination form in immediate preceding year, he/she can fill examination form this session of same class as an Ex-student category but college should declare such certificate for above fulfilment on college letter head duly signed and sealed by Principal. College should attach such original letter alongwith the Exam. Form of such candidate.

7. Self attested copy of Physically Challenged Certificate issued by the competent authority, if candidate selected and filled examination form in this category. If not found attached certificate with examination form, normal examination fee as per rules shall be charged. Copy of certificate shall not be accepted afterwards.

8. Any other document, if required as per rule.

Kindly ensure to submit the hard copies of duly filled and online approved examination forms latest by 24th June, 2024 to the University through personal messenger of college or through post. In no case examination forms either through College Messenger or Post will be received by the University after passing prescribed last date. If Examination forms not updated by college online and/or hard copies of the same not received within given timeline (any of the case or both), concerned candidate will not be allowed to appear in ensuing examinations and concerned college/candidate shall be responsible for such act.
